1. All prices and notations must be typewritten or written in ink. No erasures are permitted. Mistakes may be crossed out with corrections made adjacent and initialed in ink by the person signing the quotation.
2. Each quotation must be in a separately sealed envelope with bid number on the outside. It must be submitted to the District's Bishop Office, not later than the hour and day specified herein, at which time it will be publicly opened and read.
3. All quotations must be signed with the Firm's name and by a responsible officer or employee. Obligations assumed by such signature must be fulfilled.
4. No charges for permits and fees will be allowed over and above the prices quoted on this sheet.

5. Contracts and/or purchase orders will be made or entered into with the lowest responsible bidder meeting the specifications.
6. The right is reserved, unless otherwise stated, to accept or reject any or all quotations or any part thereof, either separately or as a whole, or to waive any inconformity in a bid.
7. In case of default by the contractor, the District may procure the articles or service from other sources.
8. Bidder must have a current California contractor's license of the appropriate class for construction of specified project. All site preparation required to meet Mono County building code(s). The following tasks are to be completed by the contractor, including all labor, materials, and permits, except as noted. Bidder will provide any plans or working drawings as necessary and approvable by the Mono County Building Department. Bidder to obtain all necessary permits.

Location: Staked and flagged area on the east side of Mattly Avenue, northwest of the Lee Vining Indian and Community Center, Lee Vining, California.

Site Preparation

Area Size: Area staked 36' x 36', fenced area, 28' x 28', to be centered in staked area, aligned with true cardinal directions, per Drawing 1, attached

Site Preparation: Site to be cleared, 36'x36', of vegetation and covered with 4-inches of California Class 2 Aggregate Virgin Base material and compacted, by contractor. Additional 20'x20' area adjoining the staked area to be cleared and covered with base material specified above for parking, with additional cleared and graveled single-lane driveway to Mattly Avenue.

Insurance: Bidder required to have, at a minimum, worker's compensation insurance, general liability insurance in the amount of \$5,000,000 and automobile liability insurance in the amount of \$1,000,000.

Location: Staked and flagged area on the east side of Mattly Avenue, northwest of the Lee Vining Indian and Community Center, Lee Vining, California.

Building Foundation

Foundation: one (1) 14.5'x13' concrete pad, 6" in depth, with perimeter footings 12" wide by 24" deep (below grade), with rebar reinforcement lengthwise in footings and wire mesh reinforcement in pad. Four (4) galvanized J-bolts for shelter hold-downs, embedded in concrete (add'l footings) per drawing; three (3) galvanized J-bolts for tower base (5'x3'x2' deep), embedded in concrete per drawing, with rebar placed both horizontally and vertically in base. Pad will be slightly above grade, but have an above-grade (above compacted Class 2 base material) exposure of no more than 1-inch. Where rebar is specified, use #3 (3/8" dia.), or larger as determined by contractor. Concrete to be finished with all corners and edges rounded off.

Insurance: Bidder required to have, at a minimum, worker's compensation insurance, general liability insurance in the amount of \$5,000,000 and automobile liability insurance in the amount of \$1,000,000.

Conduit: approximately 120 linear feet of 2-inch PVC conduit, installed and buried to code, including up to three (3) 36-inch sweeps, with pull-cord installed through conduit

Conductors: wire capable of carrying load for 100-amp, 220/240 VAC single-phase power

Connections: Tie-in to power at power pole and to breaker box on District's monitoring shelter. All connections, equipment and appurtenances necessary for installation to meet local code.

Installation of Perimeter Fence

Area Size: Fenced area to be 28'x28'

Fence: Chain-link fabric, 11 gauge, fence 6-feet high topped with 3-strand barbed wire to enclose a 28' x 28' area. Total fence length, approximately 112-feet

Gates: Frame for all gates: galvanized steel schedule 40, 1-7/8 inches in diameter
One (1) 4-foot wide walk-through gate on the north side of the west fence
One (1) 4-foot wide walk-through gate on the southeast side
Two (2) 10-foot wide gates, centered in the south fence

Posts: Terminal posts: galvanized steel schedule 40, 2-7/8 inches in diameter
Gate posts: galvanized steel schedule 40, 2-7/8 inches in diameter
Line posts: galvanized steel schedule 40, 1-7/8 inches in diameter

The Clerk of the Board is requesting bids for the site preparation (Bid No. 2017-LV1B-1); construction of a concrete building foundation (Bid No. 2017-LVB1-2); installation of a buried electrical line and electric connection to primary power (Bid No. 2017-LVB1-3); and installation of a perimeter chain-link fence (Bid No. 2017-LVB1-4); at the District's monitoring site in Lee Vining, California. All work is to be performed by licensed California contractor(s) at the District's monitoring site. Installation requires the labor and materials necessary for: 1) site preparation and application of compacted decomposed granite base; 2) construction of a building foundation for an 8'x8' shelter (provided by others); 3) installation of a buried electrical line (100 ft. in length) and connection to nearby power line; and, 4) installation of a perimeter fence (approximately 160 lineal feet).

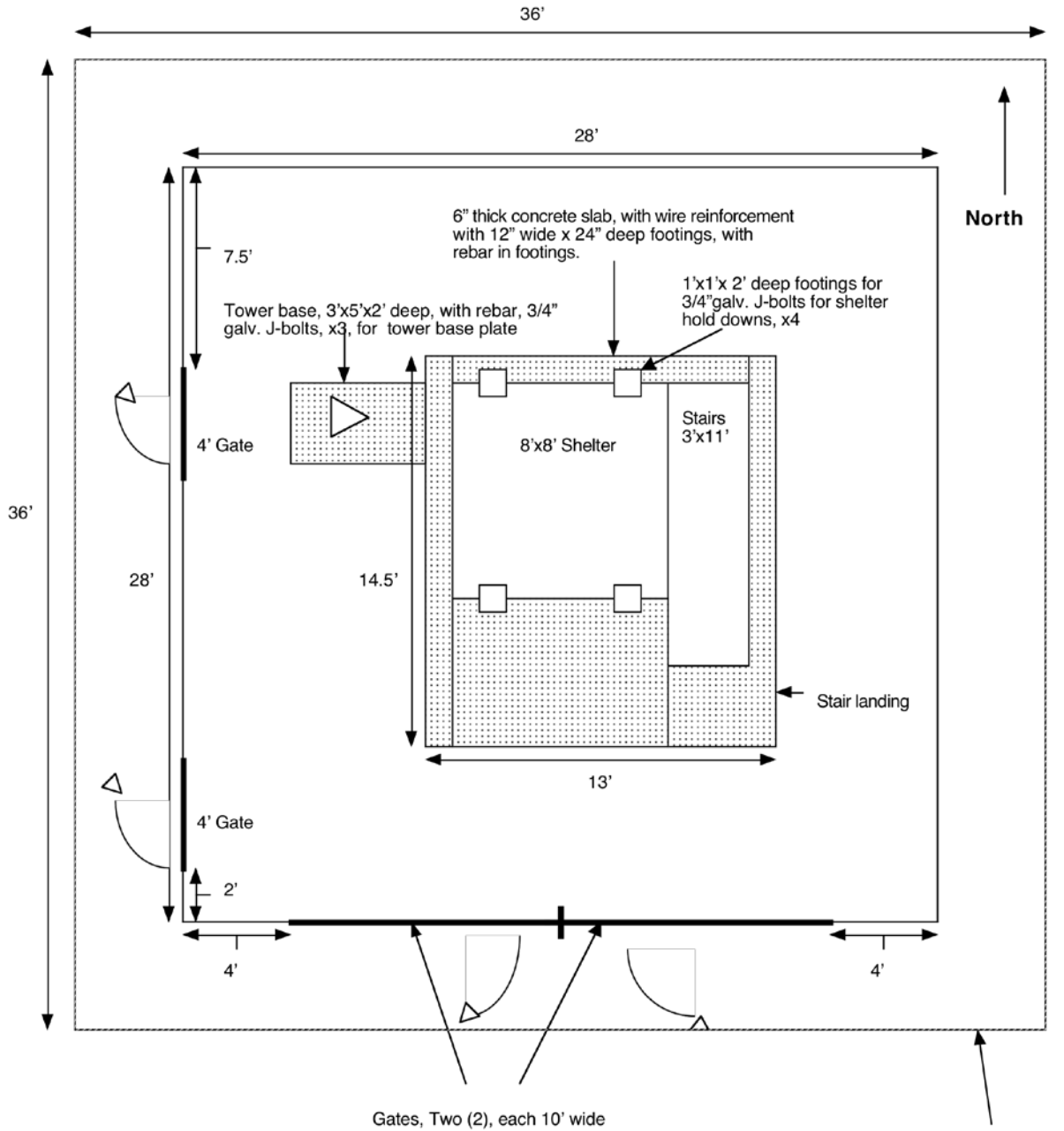

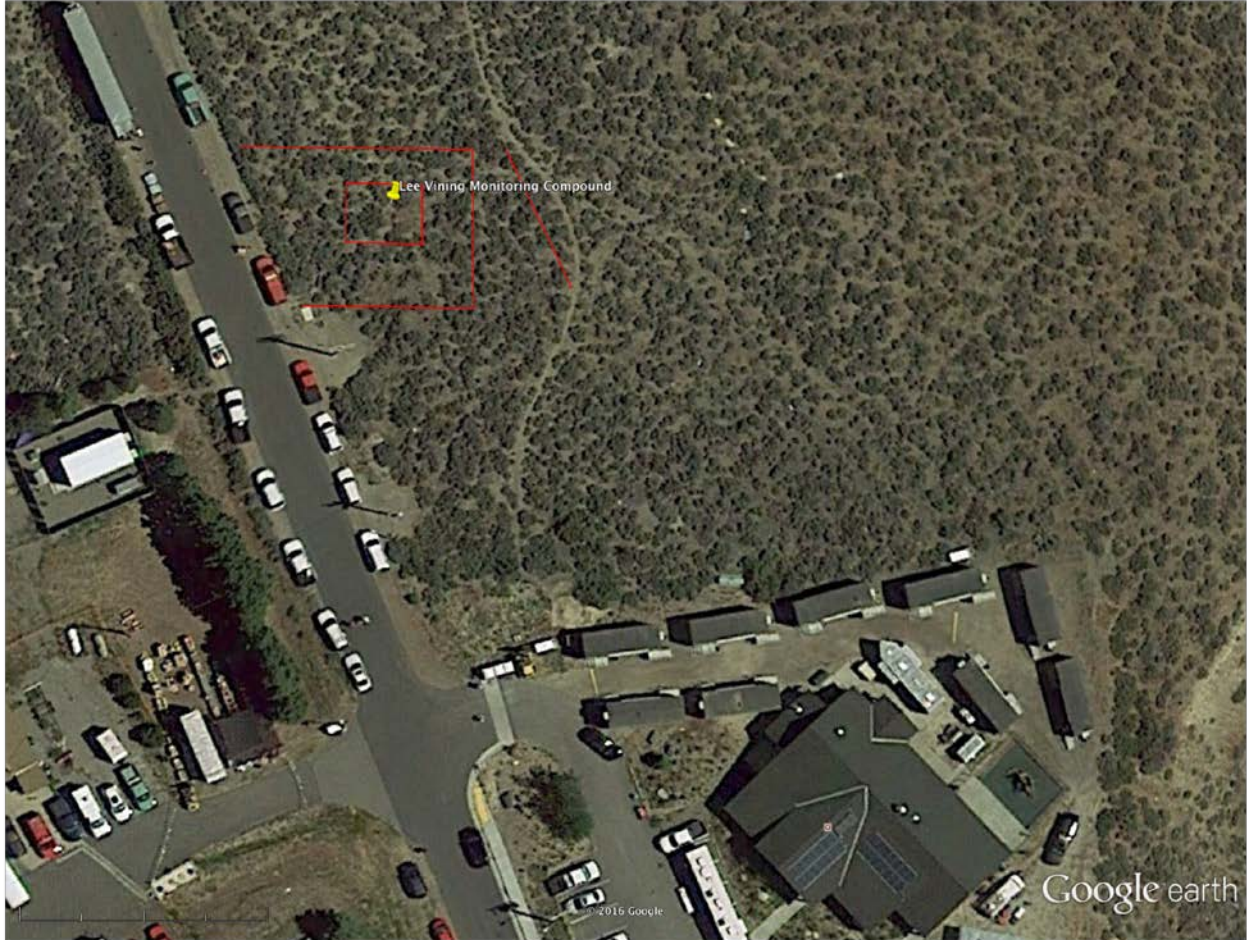
