Fee Schedule

July 1, 2021 – June 30, 2023

This document provides a summary of the current fees charged by Great Basin Unified Air Pollution Control District (GBUAPCD). Specific Rules are cited in this Fee Schedule for each fee type. Filing Fee (Rule 300 – Schedule 1).....\$100.00

ATC or PTO Revision (Rule 300 – Schedule 2)\$212.00

Inspection Fee for PTO Revisions (Rule 300 – Schedule 3).....\$162.00

Electric Motor Horsepower Schedule (Rule 301 – Schedule 1)

Any article, machine, equipment, or assembly of pieces of equipment powered by an electric motor or multiple electrical motors shall be assessed fees based upon the total maximum horsepower of the equipment in the following schedule. Aggregate processing plants, powered by line or generated electricity would have fees assigned based on this schedule.

Fuel Burning Equipment Schedule (Rule 301 – Schedule 2)

Any article, machine, equipment, or assembly of pieces of equipment that work in series in which fuel is burned (with the exception of incinerators, which have their own fee schedule) shall be assessed fees based upon the following schedule.

Diesel engines requiring permits are assessed fees based on the above schedule, after the horsepower output is converted to KBTUh by multiplying the horsepower by 7 KBTUh / bhp-hr, based upon the average diesel consumption per horsepower unit. Following is the above fee schedule converted to the equivalent brake horsepower (bhp).

Electrical Energy Schedule (Rule 301 – Schedule 3)

Any article, machine, equipment, contrivance or array of pieces of equipment that function together which uses electrical energy that is not covered under the Electric Motor Horsepower Schedule shall be assessed fees based upon the following schedule.

Incinerator Schedule (Rule 301 – Schedule 4)

Any article, machine, equipment or other contrivance designed and used primarily to dispose of combustible refuse by wholly consuming the material charged leaving only the ashes or residue shall be assessed a permit fee based upon the following schedule.

Stationary Container Schedule (Rule 301 – Schedule 5)

Any stationary tank, reservoir, or other container shall be assessed a permit fee based upon the following schedule. Gas Dispensing Facilities fees for Phase I and Phase II vapor recovery systems are based upon this schedule.

Miscellaneous Schedule (Rule 301 – Schedule 6)

Any article, machine, equipment, other contrivance or array of pieces of equipment that function together for which a Permit to Operate is required and which are not covered by any of the other schedules listed here shall be assessed a permit fee based upon the following schedule.

Geothermal Development Schedule (Rule 301 – Schedule 7)

Any stationary source of air containment emissions relative to the production or utilization of geothermal resources for which a Permit to Operate is required shall be assessed a permit fee based upon the following schedule.

Commercial Building Schedule (Rule 301 – Schedule 8)

Any secondary source consisting of a commercial building or structure shall be assessed a permit fee based on the total square footage of all buildings or structure according to the following schedule.

Fee per Square Foot.....	\$0.30
Minimum Fee per Source.....	\$115.00

Commercial Parking Schedule (Rule 301 – Schedule 9)

Any secondary source utilizing a commercial parking lot or structure shall be assessed a permit fee based upon the number of parking spaces according to the following schedule.

Housing Unit Schedule (Rule 301 – Schedule 10)

Any secondary source consisting of greater than 4 residential units shall be assessed a permit fee based on the based upon the number of residential units according to the following schedule.

Hearing Board Fees (Rule 306)

Filing Fee \$173.00

Hearing Fee

If the hearing lasts more than four hours but less than eight hours, the petitioner shall pay a hearing fee of \$150 in addition to the filing fee. If the hearing lasts eight hours or more, the petitioner shall pay a hearing fee of \$450 for the first eight hours, and \$600 for each additional eight hour period or part thereof in addition to the filing fee.

Conservation Management Practices Plan Fees (Rule 307)

Conservation Management Practice (CMP) Plans are required for agricultural operations such as cropland and animal feed operations meeting specific criteria. Rule 502 outlines the requirements for CMP plans and the exceptions when CMP plans are not required. All required CMP plans shall be assessed a CMP plan fee based upon the following schedule.

Prescribed Burning Fees (Rule 308)

All agencies conducting prescribed burns are assessed fees based upon the following schedule.

Asbestos Removal and Demolition Fees (Rule 309)

All demolitions or renovations that are required by the National Emissions Standards for Hazardous Air Pollutants (NESHAP) to file an Asbestos Notification shall be assessed fees based upon the following schedule.

**Note that while these fees are for Regulated Asbestos Containing Material (RACM, or friable asbestos material) Category I and Category II non-friable Asbestos Containing Material (ACM) will be considered as RACM, as it may become friable during a destructive demolition process, unless the person or entity completing the Asbestos Notification also provides a letter attesting to the means and methods utilized for the removal of the non-friable ACM are such that the ACM will not become friable during the demolition process. This letter needs to be prepared by a certified asbestos consultant or contractor.*
